



RELEASE AGREEMENT

In consideration of my registration for and participation in *Celebration 35* (the "event"), an activity organized in part by WDW Celebrations, L.L.C. (WDWC), I understand and agree to the following:

For purposes of this Release Agreement, the "Released Parties" shall mean any person or entity associated in any way with the event, including but not limited to WDWC, The Walt Disney Company ("TWDC") or any of its subsidiaries, superiors, or otherwise-related entities, the event's sponsoring organizations, and any other subsidiaries, affiliates, officers, directors, employees, volunteers, or individual property owners related to the event. Furthermore, for purposes of this Release Agreement, the term "Loss" shall mean all damages, losses, costs, and injuries of every kind and character including, but not limited to, all economic damages, loss of business opportunities, mental anguish, loss of consortium, loss of services, loss of companionship, and loss of employment. I represent that the registration information I submitted via the WDWC online registration system is accurate, and that at the time of my participation in the event, I will be at least 18 years of age unless accompanied by a parent or legal guardian. I warrant that I am in good health to the extent that I have no physical condition that would prevent me from safely participating in the event.

IN CONSIDERATION OF WDWC ALLOWING ME TO PARTICIPATE IN THE EVENT, I EXPRESSLY AND VOLUNTARILY ASSUME RESPONSIBILITY FOR ALL RISK OF PERSONAL INJURY, DEATH, OR LOSS I MAY SUSTAIN RELATED TO THE EVENT, OR ANY SUCH PERSONAL INJURY, DEATH, OR LOSS ASSOCIATED IN ANY WAY WITH THE EVENT, EVEN IF SUCH PERSONAL INJURY, DEATH, OR LOSS IS CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OR GROSS NEGLIGENCE OF ANY OF THE RELEASED PARTIES. I, FOR MYSELF AND MY PERSONAL REPRESENTATIVES, HEIRS, SUCCESSORS, AND ASSIGNS, IN CONSIDERATION FOR BEING INVOLVED IN THE EVENT, HEREBY HOLD HARMLESS, RELEASE, INDEMNIFY AND DISCHARGE FROM LIABILITY THE RELEASED PARTIES FROM ALL LIABILITY, CLAIMS, JUDGMENTS, DEMANDS, CONTROVERSIES, AGREEMENTS, DAMAGES, ACTIONS, AND CAUSES OF ACTION WHATSOEVER, ARISING OUT OF OR RELATED IN ANY WAY TO THE EVENT, WHETHER IN LAW OR EQUITY, NO MATTER WHAT THE CAUSE OR NATURE, AND I FURTHER WAIVE ANY CLAIM THAT I MIGHT STATE OR ASSERT AGAINST ANY OF THE RELEASED PARTIES WHICH I HAVE OR MAY HAVE AT ANY TIME ARISING OUT OF MY ASSOCIATION WITH, TRAVEL TO OR FROM, OR PARTICIPATION IN THE EVENT OR ANY OF ITS ASSOCIATED ACTIVITIES, OR IN ANY OTHER WAY RELATED TO OR RESULTING FROM THE EVENT. I ACKNOWLEDGE AND UNDERSTAND THAT BY SIGNING THIS RELEASE AGREEMENT I WILL LOSE ANY RIGHT I MAY HAVE HAD TO SUE ANY OF THE RELEASED PARTIES BECAUSE OF ANY PERSONAL INJURY, DEATH, OR LOSS I MAY SUSTAIN WHILE PARTICIPATING IN, OR ARISING OUT OF, OR AS A RESULT OF, MY PARTICIPATION IN THE EVENT, EVEN IF SUCH PERSONAL INJURY, DEATH, OR LOSS RESULTS FROM OR IS CAUSED BY THE NEGLIGENCE OR GROSS NEGLIGENCE OF ANY OF THE RELEASED PARTIES, IN WHOLE OR IN PART. I FURTHER AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASED PARTIES FROM ANY CLAIM ARISING OUT OF MY PARTICIPATION IN THE EVENT, EVEN IF THE CLAIM ARISES OUT OF THE NEGLIGENCE OR GROSS NEGLIGENCE OF THE RELEASED PARTIES, IN WHOLE OR IN PART, INCLUDING, WITHOUT LIMITATION, ALL CLAIMS BROUGHT OR ASSERTED BY ANY THIRD

PARTY AS A RESULT OF ANY PERSONAL INJURY, DEATH, OR LOSS I MAY SUSTAIN.

I acknowledge and agree that the Released Parties may subsequently use for publicity and/or promotional purposes, my name, likeness, photographs, videotapes or other recordings of me participating in the event, without any additional consideration to me beyond allowing me to participate in the event.

I acknowledge and agree that during the course of the event, I am permitted to photograph and/or record video of the activities and participants of the event for my own personal and private use. I agree that I will not release to the public through any means, electronic or otherwise, any photographs or video of the activities and participants of the event without the express written consent of WDWC.

I acknowledge and agree that, from time to time during the event, I may be permitted, at the sole discretion of WDWC and TWDC, to access certain areas not normally open to guests, and that such areas may be subject to certain restrictions not fully outlined within this agreement. As such, these areas, including those commonly known as "backstage" areas, may include certain hazards not normally encountered by guests in the course of regular operations, including but not limited to moving vehicles, construction areas, and other potential hazards. I agree that should I be granted access to said areas, I will fully comply with all regulations set forth verbally, in writing, or otherwise provided to me by any event staff, including members, employees, managers, or volunteers with WDWC, TWDC, or any other group with jurisdiction related to such specific activity. I further affirm, acknowledge, and agree that during the course of certain activities, I may be exposed to certain proprietary information, and agree not to disclose such information to others. I understand and agree that photography and recording (audio or video) is not permitted in certain areas (including some public guest areas and attractions, based upon prevailing rules at said area or attraction), and I agree to abide by such restrictions. In certain special cases, I may be required to sign and execute a Non-Disclosure Agreement as a condition of my being allowed to participate in certain experiences. I further understand and consent that due to the specific nature of certain experiences, TWDC or WDWC may enforce age restrictions which are non-negotiable and may prevent me from participating. I may be required to show legal documentation proving my age or identity in order to participate in certain activities.

I further acknowledge and agree that during the course of the event, I will conduct myself in a manner which will not bring dishonor to me or to WDWC or TWDC, or in a manner which would jeopardize WDWC's working relationship with TWDC and potentially adversely affect future WDWC events. I agree to abide by all prevailing rules and regulations involving not only my participation in the event itself, but also during other times over the course of the event, despite whether I am at an official activity of the event or not. I agree that should I engage in any such activity (defined at the sole discretion of TWDC or WDWC staff, volunteers, and related entities), I am subject to penalties up to and including, but not limited to, immediate banishment without refund from the current WDWC event and lifetime banishment from any future WDWC events. I further understand that my behavior may subject me to civil and criminal liability from other organizations, including TWDC and law enforcement officials.

I consent to and permit emergency treatment, medical or otherwise, in the event of injury or illness to myself. I further release all persons associated in any manner with the event from any claim whatsoever on account of first aid, treatment or services rendered me during my participation in the event.

I acknowledge and agree the release I have granted herein shall extend to and protect the agents, employees, representatives, assigns and successors in interest of the Released Parties.

I ACKNOWLEDGE AND AGREE THAT THE RELEASE I HAVE GRANTED HEREIN INCLUDES, WITHOUT LIMITATION, ALL DERIVATIVE CLAIMS, INCLUDING BUT NOT LIMITED TO, LOSS OF CONSORTIUM, LOSS OF SERVICES, AND LOSS OF COMPANIONSHIP, WHICH ARISE OUT OF ANY PERSONAL INJURY, DEATH, OR LOSS I MAY SUSTAIN WHILE PARTICIPATING IN THE EVENT, OR ARISING OUT OF OR AS A RESULT OF MY PARTICIPATION IN THE EVENT, WHICH MIGHT BE STATED AND/OR ASSERTED IN ANY FORUM BY MY SPOUSE, CHILDREN, FRIENDS, FAMILY, LOVED ONES, AND/OR OTHER THIRD PARTIES.

I FURTHER ACKNOWLEDGE AND AGREE THAT, DESPITE THE FACT THAT THIS RELEASE SPECIFICALLY REFERENCES TWDC AND ITS RELATED ENTITIES, NOTHING IN THIS DOCUMENT SHALL BE CONSTRUED AS OVERRIDING OR SUPERCEDING ANY OFFICIAL POLICIES, AGREEMENTS, OR OTHER LEGAL DOCUMENTATION PROVIDED BY, OR RELATED TO, TWDC AND RELATED ENTITIES. IN THE EVENT OF CONFLICT, THE DOCUMENTS PROVIDED OFFICIALLY BY TWDC SHALL PREVAIL.

I certify I am legally competent to sign this Release Agreement and I understand that the representations contained in this Release Agreement are contractual and not mere recital. I have fully informed myself of and understand the contents of this Release Agreement and I have signed this document of my own free act.

This Release Agreement and any claims associated with it or the event shall be construed according to Florida law. I acknowledge and agree that the event and/or this Release Agreement is being performed, in whole or in part, in Orange County, Florida, and venue and jurisdiction for any claims associated in any way with this Release Agreement shall only be proper in the District Court for the County of Orange, State of Florida. If any provisions of this Release Agreement shall be deemed to be unenforceable and/or void, the remainder of this Release Agreement shall not be affected thereby and the remainder of this Release Agreement shall be fully enforceable.

I ACKNOWLEDGE AND AGREE THAT I: (1) HAVE RECEIVED A COPY OF THIS RELEASE FOR REVIEW AND STUDY AND HAVE HAD AMPLE TIME TO REVIEW IT BEFORE SIGNING; (2) HAVE READ THIS RELEASE CAREFULLY; (3) HAVE BEEN GIVEN A FAIR OPPORTUNITY TO DISCUSS AND NEGOTIATE THE TERMS OF THIS RELEASE; (4) UNDERSTAND ITS PROVISIONS; (5) UNDERSTAND THAT I HAVE THE RIGHT TO CONSULT WITH AN ATTORNEY; (6) HAVE DETERMINED THAT IT IS IN MY BEST INTEREST TO ENTER INTO THIS RELEASE; (7) HAVE NOT BEEN INFLUENCED TO SIGN THIS RELEASE BY ANY STATEMENT OR REPRESENTATION BY THE RELEASED PARTIES NOT CONTAINED IN THIS RELEASE; AND (8) ENTER INTO THIS AGREEMENT KNOWINGLY AND VOLUNTARILY.

I hereby signify my acceptance of all provisions of this Release Agreement by checking the appropriate box during registration for the event via the WDWC online event registration system. If the participant of this event is a minor, the registrant confirms that he/she is the parent or legal guardian of such minor, hereby consents to the minor's participation, consents and agrees to all provisions of this Release Agreement and agrees that all provisions of this Release Agreement shall be effective as to such minor.
